**Five Best Teams** from India Round will qualify to represent India in the SAARCLAW Round of Fourth Prof. N. R. Madhava Menon SAARCLAW Mooting Competition & Law Students Conference, 2018-19 which will be held from **15<sup>th</sup> - 18<sup>th</sup> February, 2019.** Researchers from these **Five Best Teams** will be the presenters in Fourth Prof. N. R. Madhava Menon SAARCLAW Students Conference 2018-19.

The two Best Law Student Awardees will be chosen by a competent jury from the top five teams selected at the India Round of the Fourth Prof. N. R. Madhava Menon SAARCLAW Mooting Competition. Best Law Student (**one Female and one Male**) will be selected on the basis of their Academic Record and Mooting Performance. These two awardees will receive LL.M. admission and fellowship of **US \$ 50,000** each from **Pennsylvania State University, School of Law, USA, provided they complete LL.B. graduation before September, 2019.**
