Please note that **only one team** from one institute/school/department is allowed to participate. **Seven Best Teams** from India Round will represent India in the SAARC Round Mooting Competition and the researchers of these teams will present research paper in the students conference in Sixth Prof. N. R. Madhava Menon SAARCLAW Mooting Competition and Law Students Conference 2020-21 to be held in **February, 2021**.

Two Best Law Student Awardees (one female & one male) will be chosen by the jury from the selected students in their final years who are participants in the India Round. The Students will be selected on the basis of their academic record, moot performance and their social vision. The awardees will receive LL.M. admission and fellowship of **US \$ 50,000** each from **Penn State University, School of Law, USA, provided they complete their LL.B. graduation before September, 2021**. Also all the seven qualifying teams shall be receiving Cash Prize worth Rs. 15,000 each.
